We thank you for your business. We pride ourselves on providing you with unique apparel, promotional products, and services.

The information noted here applies to advertising products and apparel only. Suppose receiving Professional Services, including but not exclusive to developing marketing plans, e-marketing, marketing, advertising campaigns, graphic design, public relations, direct mail development, market research, or desktop publishing. Other Terms and Conditions apply. Contact your account representative for further information. Because Big Spirit, Inc. provides a wide range of services, we may ask you to review and accept supplemental terms that apply to the products or services you receive. Upon agreeing to work with Big Spirit Promo (a division of Big Spirit, Inc), you fully agree to be governed by our terms and conditions.

These Terms and Conditions may NOT be altered, supplemented, or amended by using other documents unless otherwise agreed in a written agreement signed by both you and Big Spirit Promo (a division of Big Spirit, Inc). If you do not receive an invoice or order acknowledgment regarding your purchase, please contact your sales representative, who can assist you in obtaining a copy.

Inventory and Selection Availability: Upon placing your order, some items listed may be phased out or discontinued by the manufacturer. Upon placing your order, item(s) availability and inventory will be confirmed.

Pricing: The quote is good for 5 business days from the date it is provided to the customer (Pricing on electronic items may change on a shorter timeline). Order changes may affect applicable charges (increasing or decreasing final cost). Please note any additional charges mentioned under "Additional Charges." Quotes do not include possible applicable shipping and handling charges or taxes.

Payment Terms: Payment must be made on the terms noted in the quote. Pre-payment may be required. **Shipping or additional charges applicable to the order may be billed separately after pre-payment upon final shipping**). Payment terms may be made available upon request, review, and approval. Payment is accepted via cash, check, and credit card. We accept most credit and debit cards. Credit card payments will incur a 3.5% processing fee.

_____ **Payment Agreement:** You agree to pay the order balance by the TERMS DEADLINE shown on the invoice. The terms begin on the invoice date and not on the date received; any **balance overdue will have interest charged of 10% per day of the cumulative amount daily until paid.**

_____ Accounts will be frozen until an account is paid in full. We reserve the right to send any delinquent accounts to collections to collect the balance of the account, late fees, and any additional fees incurred to collect.

All shipments inside the United States are subject to the sales tax at the point of delivery unless a valid reseller certificate or current tax exemption certificate is provided in advance, or a letter in writing is received requesting the backing out of taxes, and the client agreeing to submit, the "Use Taxes" applicable to their state. Applicable taxes will be invoiced regardless of whether they are reflected in the quote.

_____ **Price Escalation:** The client must provide all necessary information for Big Spirit Promo to begin producing their order within 5 business days after we receive a signed quote. Any delay in receiving necessary assets may incur all new pricing and fees applicable when receiving the final assets to start production.

Order Release: Once payment has been received, processed, and payment confirmed/ cleared. Orders will then be released to production unless you have credit terms established in writing with us.

_____ Order will be released for total production once art approval is received (written or verbal). Orders cannot be canceled once art approval has been received.

Art and Design Fees: Artwork must be camera-ready and supplied in vector format (.ai or .eps). Any needed or requested updates to your artwork or design services start at \$125/hr. 1 hr. minimum will be charged for all requests.

The release of vector art or files created or updated by Big Spirit Promo (a division of Big Spirit, Inc) may be charged a minimum of \$85.00 per file. This charge is in addition to any applicable costs related to the file's creation and or update.

Art Requirements:

- Acceptable files must be in vector format: .ai or .eps with text in outlines (text not created to outline may not open properly). Art not vectored or correctly set is subject to redraw/art fees.
- Unusable print file types: .pdf, .gif, .png or .tiff
- Resolution: 300 dpi or better (600 dpi is optimal)
- PMS Color Match: We will match all print colors as close as possible to your branded artwork. If it's critical, colors are exact PMS matches. Please provide those PMS #s. Additional costs for PMS matching (if available) may apply.

Placing Order: The following information is required to process your orders faster and more accurately. Missing information and delays in responses may extend the completion time of your order. Big Spirit, Inc. must receive a signed order approval before the order can proceed to production.

We do not do proof work on spec or provide proofs with estimates. Any requested proofs may incur a charge at a minimum of \$20.00 per proof depending on the product and may delay your order's production. **PROOFREAD THE JOB CAREFULLY AND NOTE ALL APPLICABLE DETAILS.** The final examination for accuracy is your responsibility. **UPON SIGNING THE PROOF, YOU TAKE FULL RESPONSIBILITY FOR ANY ERRORS OTHER THAN THOSE MARKED UPON THE PROOF.** Revisions requested after we receive your Approval will result in additional charges.

Virtual Mock-Up and Art-Proof:

**With your order:*

- We encourage you to request an "art-proof" for Approval before production.
- There may be a nominal cost for mockups and art proofs. Talk with your rep.
- Once an order is submitted, upon request, we will send an art proof for approval, showing the art's approximate print size and placement.
- Without approval for the art proof, the order will not be moved into production.
- **Disclaimer:** The proof represents a digital version of the intended final visual product. **IT DOES NOT GUARANTEE the final product print, color, size, or placement.** Slight variations in the product materials, print color, and or quality may result in ex. Small lettering may fill in. Spec Pre-Production Samples

When your brand colors are critical, consider having a pre-production Spec sample made: An actual physical sample of the finished product before it goes to total production. Why consider? Slight variations can occur in finished products due to, but are not limited to, product materials, print inks, printing equipment and processes (CMYK vs. RGB we see on our computer screens), and the finishing process. Ask for availability and costs.

Order Cancellations: Orders cannot be canceled once art approval has been received. All cancellations must be requested in writing and are subject to approval by Big Spirit Inc; Any costs incurred up to the point of cancellation acceptance will be the client's responsibility which may include but not be limited to restocking fees, etc. Rush orders may not be canceled.

Over/Under Runs: Order quantities may fluctuate +/- 5%. Exact quantity requests: Start at a \$40.00(v) fee.

Spoilage: Big Spirit Inc. will not be held responsible for spoilage up to 5%. Imprints on defective items supplied by customers will be billed. Extra production time will be needed if we need to replace any items. Big Spirit Inc. will not be responsible for damages such as profit loss from spoiled or defective products. We will not replace customer-supplied items. Any customer-supplied items such as these are provided at the customer's risk. We highly encourage our customers to purchase products from us. If your orders require exact quantities, we encourage you to buy extra pieces.

Sample Requests: Samples may be available upon request. **Clients are responsible for all costs to obtain, including the samples. All samples are non-returnable and non-refundable.** All applicable sample shipping expenses will be the responsibility of the requesting party. Relevant sample expenses will be billed upon the customer placing a final order. If an order is not received within 30 days of receiving samples, a bill will be provided and payable to Big Spirit, Inc.

Trademarks: The customer accepts full responsibility for claims or litigation arising from alleged infringements of patents or copyright on any requested design or copy.

RETURN & EXCHANGE POLICY

Limited returns are available on non-customized items. **Except for manufacturing defects, we cannot accept returns on personalized/custom imprinted promotional items. Please check your order for manufacturer defects immediately upon arrival, as there are no returns after 48 hours from receipt of the order.**

IMPORTANT: Big Spirit DOES NOT GUARANTEE an exact and consistent replication of a product(s) and branding in order. Slight variations in product materials, craftsmanship, color, print placement, and quality may occur by accepting your order with a signature or emailed "Approval" on a quote, sales order, order acknowledgment, or other document referencing your approval. You accept the entire order as is without question or refund. Exceptions apply. See below.

The items must meet the following requirements:

1. Item must be returned within 48 hours of delivery.
2. Items must have been directly purchased from Big Spirit, Inc. only (not through third parties).
3. Items must be unused, unworn, and unwashed.
4. Items must have all original tags and labels attached to the article.
5. All printed products (books, calendars, posters, etc.) and all other items must be unopened and in the original packaging.
6. Items should be returned in their original packaging.
7. Refunds will be given as merchandise credit, exchange, or credit to the original payment method.
8. Restocking fees on some items may apply.

To return a defective product or to apply for a product exchange:

1. The customer is responsible for any return shipment costs.
2. On items deemed defective or an error made by us on your original order, Big Spirit, Inc. will arrange for shipping back to our company.

3. We are not responsible for lost or stolen merchandise. All used or missing items from the original order will be null and void from returns, exchanges, or refunds.
4. Any costs associated with reprocessing items because of the customer's incorrect information will be the customer's sole responsibility.
5. It is in our sole and absolute discretion whether the defective product will be replaced or repaired.
6. "Even exchange" items will be sent only after the returned items are received.

Nonrefundable: Electronic media (DVDs, CDs, mp3, and other downloadable files): Owing to piracy issues, electronic media cannot be returned for reimbursement.

APPAREL ORDERS

Required Order Information: Order approvals are created and emailed to the customer at the order entry stage of the process (not applicable for reorders unless requested). Big Spirit Promo (a division of Big Spirit, Inc) must receive a signed or email order approval before the order can proceed to production.

Imprint Sizing: Customer-specified print sizes must meet our imprint guidelines. Designs will be sized for the smallest-sized garment within an order. Ex. An order contains both youth and adult-sized garments that are to receive the exact imprint. The imprints will be sized for the smallest youth-sized garment unless the customer approves runoff.

Imprint Location: The imprint placement will be specified on your mockup. The location definitions are listed on our imprint guidelines. The precise location may slightly differ in each garment.

Order Revisions: Order revisions are generally not accepted once an order is approved. Ex: A day after you place your order and sign your quote, you decide to change designs, garment colors, quantities, or sizes. If management accepts your change order, your scheduled due date will also change, and you may incur extra charges. These charges may include but are not limited to shipping, art, embroidery digitizing, and general processing.

Cancellations: Orders cannot be canceled once art approval has been received. Cancellations of approved orders will be subject to any fees incurred in processing your order. Rush orders may not be canceled. All cancellations must be made by written request.

Returns/Refunds: Defective or misprinted items may be returned for a full refund within 48 hours of receiving them. This does not include defective or misprinted items supplied by customers. All returns and refunds must be approved by management. Items must be unused, unworn, and unwashed. Items must have all original tags and labels attached to the article.

****Due to the many chemicals, processes, and equipment used to clean and care for garments. Once a product is washed, any color changes, fits, material appearance, durability, and longevity become the customer's sole ownership. Garments become nonrefundable.**

WHEN YOUR RETURN HAS BEEN RECEIVED, ACCEPTED, AND PROCESSED, WE WILL CREDIT FOR THE AMOUNT OF THE RETURN, LESS RE-STOCKING FEES, SHIPPING AND HANDLING, AND ANY APPLICABLE TARIFFS, TAXES, OR OTHER FEES. PLEASE ALLOW 2 BILLING CYCLES FOR THE REFUND.

SEVERABILITY CLAUSE- If any provision of this agreement or the application of any of its conditions to any party or circumstance is held invalid or unenforceable, the remainder of this agreement and the application of those provisions to the other parties or events will remain valid, and in full force and effect.
